# 1. CALL TO ORDER

The meeting of the Red River Waterway Commission was called to order by Chair Designee, Troy Roussell, in the Board Room of the Red River Waterway Commission Office located at 5941 Highway 1 By-Pass in Natchitoches, Louisiana.

By motion of Commissioner Clark, seconded by Commissioner Lattier, the agenda was unanimously approved. Comments from the public were called for, however, none were offered.

#### 6. APPROVAL OF MINUTES

By motion of Commissioner Simpson, seconded by Commissioner Clark, the minutes of the September 17, 2025, meeting were unanimously approved.

# 7. TREASURER'S REPORT

By motion of Commissioner Lattier, seconded by Commissioner Clark, the Expenditures, Financial Statements, Investment Reports, & Fund Balance Report for the month of September 2025 were unanimously approved.

## 8. COMMITTEE REPORTS

#### a) Contracts

Consideration of Approval of Change Order No. 1/RRWC Project No. 24-07/Contract No. RRW-843/INorth Adventure Trails/Phase 1D/Multi-Use Trails: By motion of Commissioner Clark seconded by Commissioner Lattier, the Commission unanimously approved change order number 1 providing for a decrease in contract cost in the amount of \$81,171.48, bringing the total construction cost to \$1,267,013.52.

<u>Consideration of Approval of 2026 Contracts List:</u> By motion of Commissioner Clark, seconded by Commissioner Lattier, the Commission unanimously approved the 2026 contracts list as presented.

# b) Land Management & Legal Affairs

<u>Consideration of Award of Public Bid Land Lease/Kateland Realignment/Parts of Tracts 1, 3, 5 & 7/100 Acres:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Lattier, the Commission unanimously approved award of bid to KISS Property Management, LLC for \$10,500.00 for the 5-year term.

<u>Consideration of Approval of Land Lease Extension/St. Maurice Realignment/Part of Tract 2/23.6 Acres:</u> By motion of Commissioner Crutchfield, seconded by Commissioner Clark, the Commission unanimously approved the request from JH Global Interests, LLC for a 5-year lease extension of the above described property for \$3,245.00 for the 5-year lease extension term.

Consideration of Approval of Offer to Purchase Land/INorth Adventure Trails Mitigation Property/1.8 Acre Access Road: By motion of Commissioner Crutchfield, seconded by Commissioner Clark, the Commission unanimously approved submitting an offer to purchase the Hall-Williams, LLC ownership in the 1.82 acre road for a total price of \$38,000.00, and an offer to purchase the Key Exploration, Ltd ownership in the 0.82 acre portion for \$17,500.00, a corresponding budget amendment in the amount of \$56,000.00, and authorizing Executive Director, Colin Brown, to execute the Buy Sell Agreement and Deed documents upon acceptance of the Commission's offers.

## c) Recreation

**Recreation Area Status Report** - Mr. Marcus Long highlighted the prepared report provided in the meeting packet, noting that there had been 130,000 visitors to the District recreation areas during the month of September 2025. Updated maintenance items include, but not limited to:

- Dredging: two hydraulic dredges are working oxbow areas and a spud barge is headed northward
  - Aquatic sprayers have returned to the river to combat the vegetation

# d) Ports

Consideration of Funding Request/Central Louisiana Regional Port/Beaver Lake Renewable Energy: By motion of Commissioner Lattier, seconded by Commissioner Crutchfield, the Commission unanimously approved the request to fund up to \$3,750,000.00 for the development of a general cargo dock, liquid dock, heavy haul access road, and associated utilities for the Beaver Lake Renewable Energy project. The Cooperative Endeavor Agreement to be presented at the November Commission meeting.

- Smaller/private fishing tournaments have been taking place on Red River
- Shreveport-Bossier Sports Commission will be hosting the F1 Power boat racing championship in 2026

  - USACE Vicksburg District is not a part of the government shutdown and currently working. However, some reimbursements are on hold
  - 12' Channel Study Next week a working draft will be available for public review for thirty (30) days
  - President's Budget 2026 Funding request to LA DOTD for the continuation of the 12' Channel Study. Request for deviation at Lock and Dam 2 due to the lock itself
  - End of February 2026 will be a Command Visit to the Shreveport-Bossier area in regards to the 12' Channel project. Red River Waterway Commissioners are welcome to attend
  - Lock 2 approach project has been awarded and hope to begin in November. Will take approximately 30 days to complete
